### Nebraska Statutory Responsibilities

The planning commission shall (a) make and adopt plans for the physical development of the municipality, including any areas outside its boundaries which in the commission's judgment bear relation to the planning of such municipality and including a comprehensive development plan, (**b**) prepare and adopt such implemental means as a capital improvement program, subdivision regulations, building codes, and a zoning ordinance in cooperation with other interested municipal departments, and (c) consult with and advise public officials and agencies, public utilities, civic organizations, educational institutions, and citizens with relation to the promulgation and implementation of the comprehensive development plan and its implemental programs.

- Held public hearing to consider conditional use permit application of Boone County to erect a radio tower within the TA Zoning District:
  - Application was approved with the following conditions:
    - Project meets County road setback requirements;
    - Project receives FAA approval;
    - Project receives Nebraska Department of Aeronautics approval; and,
    - Project meets any and all other local zoning regulations.

- Reviewed Fiber Optic infrastructure available in Albion and discussed future availability to businesses and residents.
- Planning Commission reviewed and recommended approval of Phase I of the Anderson Subdivision infrastructure improvement plans as submitted by Engineer John Zwingman on behalf of Niewohners.
- Reviewed the nuisance abatement program. Officer Predmore explained the process they have been utilizing to enforce the ordinance.
